QUALIFICATIONS

Qualification Definitions for Spaniels as per J7i(2).

Open: Preference in the draw will be given to dogs which have gained awards 1st, 2nd or 3rd in an Open Stake or 1st in All Aged or Novice Stakes.

Novice: Dogs NOT to have gained a 1st, 2nd or 3rd in an Open Stake, or 1st in All Aged or Novice Stakes.

All our trials are held under Kennel Club Ltd Rules and Field Trial Regulations.

Should circumstances so dictate, the Club, in consultation with the Judges, may alter arrangements as necessary.

Such changes and the circumstances surrounding them will be reported to The Kennel Club at the earliest opportunity.

No modifications will be made to this schedule except by permission of The Kennel Club, followed by an advertisement in the appropriate journals if time permits before the closing of entries.

The Kennel Club reserves the right to refuse any entry, except that this shall not apply in terms of the preference in the draw.

Substitutions will be permitted, subject to the qualifications above.

Entry fees will be taken for withdrawal from the trial less than 48hours before the trial date without a valid reason.

THE DRAW

The draws for these trials will be conducted at the addresses stated above on the dates and times given.

Results of the draw and trial will be shared on the CGDS website.

Entrants on the run list will be contacted directly to confirm their place. Reserves will be contacted on availability of a space.

Should you wish to receive a paper copy of the results please include a self addressed envelope, including stamp, with your entry form and cheque.
